
# 2014 Algonquin's Art on the Fox

## **Eligibility**

Algonquin's Art on the Fox is open to all artists. All artwork must be original, designed and executed by the accepted artist. Work done by a production studio is not acceptable. No kits, imports, crafts, manufactured items, resale goods, or product line reps are allowed.

### Setup

Booth space is  $10^{\circ}$  x  $10^{\circ}$ . Setup can start at 5:00pm Friday. Be prepared for uneven or slightly sloped ground. Tear down will not begin until the end of the show. Artists who setup late or shut down early will compromise their eligibility to participate in future shows. On-site security is provided 5pm Saturday to 8am Sunday.

#### **Awards**

Judging will take place at 10:00am on Saturday. Ribbons and monetary awards will be given out on Saturday evening at an artist reception, to which all participating artists are invited.

#### Sales and Taxes

All proceeds go to the artist. Each artist is responsible for collecting and reporting sales tax (7.75%) on all sales made during the show.

Failure to comply may result in the removal of an Artist from AAF and jeopardize participation in future shows. AAF has permission to publish slides and/or photographs of my work, my booth or of me for purposes related to the promotion of the event, past, present or future.
