

The Village recognizes the need for implementation of a strategy to revitalize existing properties within the boundaries of the Redevelopment Project Area and to stimulate and enhance private development. Private investment attraction and redevelopment of properties are key components of the strategy. The needed private investment may only be possible by the use of tax increment financing (TIF) pursuant to the terms of the Tax Increment Allocation Redevelopment Act Illinois Compiled Statutes, Chapter 65, Section 5/11-74.4-1 et seq., as amended. Incremental property tax revenue generated by redevelopment activities will play a decisive role in encouraging private redevelopment. Site conditions that may have precluded intensive private investment in the past will be eliminated. Ultimately, the implementation of the Redevelopment Plan and Project will benefit the Village and all the taxing districts which encompass the area in the form of a significantly expanded tax base.

The following represents some significant highlights during the reporting period:

#### **Block 1 Redevelopment**

The Block 1 Redevelopment project includes the area roughly bounded by Main Street, Algonquin Road, Harrison Street, and Crystal Creek in Algonquin. In the prior reporting period, the Village acquired the

parcel located at 107 West Algonquin Road, which is mid-block between Main Street and Harrison Street. With this acquisition, the Village has assembled the four (4) parcels (approximately 1.1 acres) that are contiguous to Algonquin Road. Substantial portions of the Block 1 parcels are within the floodplain. To address this, engineering work continues to progress on a river walk connection between Towne Park and Cornish Park which will also correcting on-going erosion and flooding issues on the Block 1 parcels. The



improvement to the creek flow and capacity will ultimately remove significant portions of Block 1 from the floodplain and allow greater flexibility to manage storm water storage requirements for any future development in the area. Future property acquisition (full or partial) in this area may be necessary to facilitate completion of other public purposes and infrastructure improvements.

Property acquisition in this area supports project objectives by promoting the redevelopment of existing vacant or underutilized property located within the Redevelopment Project Area and further by providing for the necessary infrastructure and storm water management improvements and upgrades in the area.

#### **Downtown Redevelopment and Streetscape**

Significant construction activities in the redevelopment area were performed during the reporting period. The most notable work performed during this reporting period was in the area of South Main Street between Illinois Route 31/Huntington Drive to the Crystal Creek bridge, just south of Algonquin Road. In early 2018, construction began transforming Main Street into a beautiful, pedestrian friendly environment while helping to preserve the character and history of the area. This phase of construction includes updated utilities, street improvements and enhanced pedestrian amenities. Specifically, electric and

telecommunication utilities were relocated from overhead poles/wires to underground, with appropriate service connections made to private property. Other utilities replaced and reconnected include water



main and sanitary sewer. This work included the replacement of lead service lines to private property. At the end of the reporting period, all overhead and underground utility work was completed, along with road surface improvements, brick paver sidewalks and parking stalls, ADA retrofits and landscaping. Work on The Plaza (adjacent to Historic Village Hall, 2 S. Main St.) and the Crystal Creek Bridge is anticipated to be completed during the fiscal year ending 2020

reporting period.

Secondly, shifting north on Main Street between Algonquin Road and Riverview Drive, water main, sanitary sewer, and lead service lines were replaced along this stretch during the reporting period. Surface work on the roadway and sidewalks will occur at a later date.

Thirdly, right-of-way acquisition at the intersection of North Main Street and Cary-Algonquin Road occurred during the reporting period. A roundabout intersection is proposed at this location and there was necessary land acquisition at the southwest and southeast corners of the intersection.

Lastly, significant progress was made on engineering design work related to future phases of construction in the area. Specifically, this includes Stage 2 (the approximate area of Harrison Street from Front Street to Brook Street, including Edward Street), and Stage 3 (the approximate area of Harrison Street from Front Street to Washington Street, including La Fox River Drive.

Christopher Burke Engineering is performing the engineering work as it relates to the street improvements, Engineering Enterprises Incorporated is performing engineering work related to the water distribution system, and Trotter and Associates is performing work related to the sanitary conveyance system.

At the time of this report, the Village has seen several permit applications for building improvements along South Main Street, in what is hoped to be a long-term trend of private investment in the area leveraged with public infrastructure improvement. This includes expansion of existing businesses (Bold American Fare and Cucina Bella) and new businesses to the area (Black Bear Bistro, Bullseye's Pub and Eatery, Cattleman's Burger and Brew, Precision Eye Care).

These activities support the project objectives of providing infrastructure that is adequate in relation to Village redevelopment plans and coordinate such infrastructure provision with redevelopment activities.
