IEPA Sewer Loan Increase Request - #5550, #5553 & #5554

Trotter & Associates, Inc. (TAI) is requesting the Village of Algonquin's assistance to provide updated financial information to increase the approved loan amounts for three sanitary sewer/ wastewater projects funded by the Illinois EPA's Water Pollution Control Loan Program. Please return all information and signed documents to Jillian Kiss - j.kiss@trotter-inc.com at TAI's St. Charles office.

Requested Information from Client:

- 1. Please provide Debt Obligations (and amortization schedules) currently being paid by the revenue source pledged to repay the loan
- 2. Please describe plans for debt issuance over the next three years for the wastewater system.
- 3. Please provide a 5-year financial projection using the IEPA's sample worksheet, or similarly formatted worksheet. A copy of a projection prepared by the Village in 2018 is enclosed for reference. Please include the debt service associated with the full amount authorized to borrow (\$26,200,000). Estimated annual payments for each of the three sewer loans are listed in the table on Page 2.
- 4. Please provide a written narrative to accompany the financial projection.
- 5. Please provide a Loan Authorizing Ordinance (AO) to authorize borrowing \$26,200,000 from the IEPA Water Pollution Control Loan Program. Village Ordinance 2018-O-24 authorizes borrowing up to \$24,703,400. The Village may either rescind Ordinance 2018-O-24 and pass a new, larger AO; or enact a separate Ordinance authorizing the balance (\$1,496,600) to be borrowed for construction expense overages associated with the loan projects.
 - a. IEPA recommends that a draft of the Ordinance be reviewed by Ms. Stephanie Flowers, IEPA Legal Counsel. She can be contacted at Stephanie.Flowers@illinois.gov. The authorizing amount for the project is defined on Page 2.

6. A legal opinion that the enacted ordinance is in accordance with the State statute with respect to the validity and enforceability of the loan recipients' obligations and the absence of conflicts with other agreements, bonds or ordinances. The legal opinion of Ordinance 2018-O-24 is enclosed for reference.

The total Authorizing Ordinance amount should equal \$26,200,000.

ORDINANCE NO. 2021 - O - ____

AN ORDINANCE AMENDING ORDINANCE 2018-0-24 AUTHORIZING THE VILLAGE OF ALGONQUIN, KANE AND MCHENRY COUNTY, IL, TO BORROW FUNDS FROM THE

ILLINOIS ENVIRONMENTAL PROTECTION AGENCY WATER POLLUTION CONTROL LOAN PROGRAM AND REPEALING ORDINANCE 2021-0-06 THAT PREVIOUSLY AMENDED ORDINANCE NUMBER 2018-0-24.

WHEREAS, the Village of Algonquin, McHenry and Kane Counties, Illinois, is a home rule municipality as contemplated under Article VII, Section 6, of the Constitution of the State of Illinois, and the passage of this Ordinance constitutes an exercise of the Village's home rule powers and functions as granted in the Constitution of the State of Illinois; and

WHEREAS, pursuant to Ordinance 2018-0-24, the Village President and Board of Trustees of the Village of Algonquin ("the Corporate Authorities") determined that it was advisable, necessary, and in the best interest of the public health, safety, and welfare to improve the Village's Wastewater Treatment Facility and to make Certain Utility Improvements to Downtown Streetscape Stages 2 and 3, described collectively in that ordinance as the "Project"; and

WHEREAS, pursuant to Ordinance 2021-0-06, based on final costs for a portion of the Project, the Corporate Authorities further determined that it was appropriate to request a loan increase from the State of Illinois' Water Pollution Control Loan Program to cover an additional \$202,700 in expenses for the Project for a total loan amount of \$24,905,990.09; and

WHEREAS, the Project costs for the entire project – including Wastewater Treatment Facility Phase 6B Improvements, Downtown Streetscape Stage 2 Utility Improvements and Downtown Streetscape State 3 Utility Improvements -- have now been received, and it has been determined by the Village's consulting engineers, Trotter and Associates, that the Project costs and associated loan amounts needed for the project shall be as follows:

WHEREAS, based on the Village's consulting engineers analysis, the total revised estimated loan amount should be \$26,200,000 (instead of \$24,703,400 as previously determined by Ordinance 2018-0-24 and instead of \$24,905,990.09 as previously determined by Ordinance 2021-0-06) which is a total increase in the amount to be borrowed of \$1,496,600 over the original approved loan amount to cover construction expense overages associated with the Project.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the VILLAGE OF ALGONOUIN, McHenry and Kane counties, Illinois, as follows:

SECTION 1: That Ordinance 2021-0-06 is hereby repealed.

SECTION 2: That Section 2 of Ordinance 2018-0-24 passed on August 21, 2018 shall be amended to read as follows:

SECTION 2. DETERMINATION TO BORROW FUNDS

It is necessary and in the best interests of the Village of Algonquin to construct the Project for the public health, safety, and welfare, in accordance with the plans and specifications, as described; that the System continues to be operated in accordance with the provisions of the Illinois Environmental Protection Act, 415 ILCS 5/1 et seq.; and that for the purpose of constructing the Project, it is hereby authorized that funds be borrowed by the Village of Algonquin in the aggregate principal amount (which can include construction period interest financed over the term of the loan) not to exceed \$26,200,000.

SECTION 3: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 4: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 5: This Ordinance shall be in full force and effect as of March 9, 2021, subsequent to its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.
